## **INSTRUCTIONS**

- 1. All the courses are available only in English medium.
- 2. Extra classes may be held to cover the syllabus on time.
- 3. Sunday may not be a holiday. Test series will be carried out on Sundays.
- 4. Fee is to be submitted either by Cash or demand draft/local cheque drawn on SBI, favoring CATALYST Center of Excellence Pvt. Ltd. payable at Lucknow.
- 5. In case of installment (period beyond 10 days from the day of admission), an extra fee of Rs. 3000 will be charged.
- 6. In case of installment 50% fee will have to be deposited at the time of admission and rest within 55 days of taking admission.
- 7. Student taking admission for a session/batch is entitled to sit for that session/batch only. In no condition he/she will be given permission to sit for next session/batch without proper fee.
- 8. Fee once paid will not be refunded under any circumstance, including failing to turn up for the class.
- 9. Period of installment should not exceed 55 days from the day of admission. In case of failure to deposit fee in the stipulated period of 55 days student will not be allowed to attend classes till he/she completes his/her formalities.
- 10. Installment facility can be availed by those students only, who join batch within **two** months of commencement of batch.
- 11. After admission to any of the course, if there is any indiscipline or misbehavior on the part of the students, they may be expelled, without any explanation. The right to rusticate rests solely with the management.
- 12. Any dispute shall be under the jurisdiction of Lucknow High Court only.
